[REDACTED] (PROTECT IDENTITY REQUESTED), white male, age: [REDACTED] [REDACTED], Kentucky, 270/[REDACTED] [REDACTED], was advised of the identity of the interviewing agent and the purpose of the interview to be conducted. [REDACTED], thereafter, furnished the following information by telephone:

[REDACTED]'s wife is [REDACTED]
[REDACTED]

[REDACTED] stated that he never heard [REDACTED] mention the name of "Heather Teague" at any time. [REDACTED] is not personally aware of any connection between the two individuals either.

[REDACTED] met [REDACTED], approximately 1 ½ years after the abduction under investigation in present case. [REDACTED]'s vehicle broke down in front of [REDACTED]'s driveway. At that point in time, [REDACTED] told [REDACTED] that [REDACTED] (Heather Teague) remarked before the abduction that she was then thinking about being in a porn movie.

[REDACTED] explained that [REDACTED] and [REDACTED] both worked for [REDACTED] at the time of the Teague abduction. Both men somehow assisted [REDACTED] in [REDACTED] as a part of [REDACTED] business in Henderson, Kentucky. [REDACTED] [and his known associates: [REDACTED] and [REDACTED] (attorney; believed to be an attorney for [REDACTED] [REDACTED] - an eyewitness in the Teague abduction)] was ultimately convicted on federal drug charges and incarcerated.

At the same time, [REDACTED], was known to work in some fashion at the Henderson County courthouse.

[REDACTED] personally observed [REDACTED] and Dill as they assisted [REDACTED] at [REDACTED]

At some point in time [REDACTED] learned (possibly from his mother-in-law, [REDACTED] that [REDACTED] and [REDACTED] were partners with another person from Madisonville, Kentucky, in a Henderson bar known as "Rumors" [REDACTED] believes that this bar, which allegedly engaged in prostitution and nude "dancing", was opened shortly after the Teague abduction.

Prior to the opening of Rumors, however, _____ (and possibly _____) operated another bar at the corner of Adkinson Street and Clay Street in Henderson. This bar (building leased from _____; Henderson) also allegedly (according to the _____) engaged in prostitution and nude dancing - as well as the distribution of illegal drugs. _____ possibly resides at this particular location at the present time.

_____ has also heard (mostly from his mother-in-law) that _____ and _____ took pictures (including video) of underage girls having sex with prominent men at Rumors. Chuckie Collins allegedly acquired one of the videos in question and determined that _____ (maiden name; presently married; Henderson), was depicted as well as other underage girls and prominent men at the bar. This observation made Collins very mad and he personally confronted _____ about the same.

A few days later, on March 23, 1998, Collins died under suspicious circumstances while in police (Kentucky State Police - "KSP") custody. In this regard, _____ noted that KSP stated there was no significant physical contact between any trooper and Collins before his death. However, an autopsy allegedly shows clear and convincing evidence that Collins was severely beaten at some point before his death.

The next day, on March 24, 1998, one of Chuckie Collins' neighbors, _____ (at the time), saw several vehicles at Collins' residence. The individuals who drove the cars in question were also observed removing items - possibly including the porn tape described above - from inside the residence. _____ has also heard that the porn tape may have ultimately been sent to some location in Illinois.

(Henderson), may possess additional information regarding the alleged beating. _____ further opined that _____ knows a lot about the situation surrounding _____ (Chuckie Collins) death. _____, however, is extremely afraid to cooperate with the investigating agent or anyone else at this time. Several unknown people have allegedly told _____ keep quiet or someone else will be killed (implying that Chuckie Collins was murdered).
